The District of Minnesota sponsored a community outreach event aimed at those with developmental disabilities called *The Unfinished Journey: Civil Rights for People with Developmental Disabilities and the Role of the Federal Courts.*

The event included a sold-out CLE, followed by an evening public reception that unveiled a set of 20 educational banners on the history of disability rights legislation in Minnesota. Also at the evening reception was the opening of *I AM*, the court's newest juried public art exhibit by artists with intellectual disabilities.

The evening also included spoken word pieces by authors Alex Junge and Ethan Bussiere, and a performance of the song "You Need a Friend" by world-renowned musician Tommy Barbarella (a former member of Prince's recording and stage band), his daughter Mariella (who lives with Williams Syndrome), and a group of Mariella's friends.

The CLE and reception were projects of the Court's Public Outreach Committee and were co-sponsored by the Minnesota Chapter of the Federal Bar Association, the Minnesota Governor's Council on Developmental Disabilities, the Minnesota Disability Bar Association, and the non-profit organization MSS.

Naturalization Ceremony at the Des Moines Public Library

United States Chief Magistrate Judge Helen Adams presided over a Naturalization ceremony at the downtown Des Moines Public Library in Des Moines, Iowa, on March 29, 2024. Eighth Circuit Court of Appeals Holds Special Session at University of North Dakota with Jurist-in-Residence

North Dakota Law - The University of North Dakota School of Law welcomed United States Eighth Circuit Court of Appeals Judge Ralph Erickson as its 2024 Rodney S. Webb Distinguished Jurist-in-Residence. The highly anticipated visit marked the return of the jurist-in-residence program after an eleven-year hiatus.

During the two-day visit, Judge Erickson visited the Intellectual Property and Federal Indian Law classes, engaged with members of the North Dakota Law Review and the Student Trial Lawyers Association, attended a breakfast with students and a celebratory luncheon in his honor, and participated in a federal clerkship panel with United States Bankruptcy Judge Shon Hastings, United States Magistrate Judge Alice Senechal, and United States District Judge Daniel Traynor.

The highlight of the visit was a special session held by the United States Court of Appeals for the Eighth Circuit in the School of Law's newly remodeled VandeWalle Courtroom with United States Eight Circuit Court of Appeals Judges Ralph Erickson, L. Steven Grasz, and Jonathan A. Kobes presiding. The special session heard three oral arguments and were open to law students and the public.

Judge Erickson capped off his visit to University of North Dakota Law with a reception at the school of law co-hosted by the State Bar Association of North Dakota and the Federal Practice Committee.

Civics Event Held in Fort Smith

The Western District of Arkansas hosted 80 students and 15 instructors and administrators from Fort Smith schools at a civics event and mentor/student lunch on Thursday, January 25, 2024. Also included were eight local judges, members of the local bar association, and representatives from the district United States Attorney's Office, the Federal Public Defender's Office, and the United States Probation Office.

The event was held at the Isaac Parker Federal Courthouse in downtown Fort Smith, Arkansas. Participants took part in a mock trial followed by lunch in which students got to meet and collaborate with federal and state court judges, attorneys, and other court professionals.



Sioux City Hosts Criminal Justice Students

On January 4, 2024, the Northern District of Iowa hosted students from a Newell– Fonda High School criminal justice class at the Sioux City Courthouse. The students were able to watch a sentencing hearing and then had the opportunity to speak with United States District Judge Leonard Strand, Assistant United States Attorney Kraig Hamit, Assistant Federal Public Defender Timothy Herschberger, Pro Se Law Clerk Matt Winter, Legal Advisor to Judge Strand Audrey Felderman, two United States Marshals, two United States Probation Officers, and Court Reporter Shelly Semmler. Students were then treated to lunch in the jury assembly room of the courthouse.

Eastern and Western Districts of Missouri Host Annual Street Law Teacher Workshop

The Eastern and Western Districts of Missouri partnered with The Missouri Bar to host the annual Street Law Teacher Workshop on February 28-29, 2024. Since 2015, the Eastern District of Missouri and The Missouri Bar have co-hosted the Street Law program each spring in St. Louis. This high-quality professional development opportunity brings high school teachers in contact with judges, attorneys, law professors, and skilled presenters to learn effective strategies for teaching about the courts and the law.

The 2024 edition was special because it represented the first time the Western District of Missouri joined the collaboration, hosting the program at the Christopher S. Bond Courthouse in Jefferson City, Missouri's capital. It was also significant because of the return to an in-person, two-day format, after online one-day programs in 2021-23.

The theme of the 2024 program was "The First Amendment and Social Media." Facilitators from Street Law guided the teachers through sessions on fundamental rights, the First Amendment, and classroom strategies of deliberation and inquiry. The program culminated in a moot court activity during which the teachers filled the roles of justices, petitioners, and respondents after being coached by judges and attorneys. Participating teachers had the opportunity to work with Chief United States Magistrate Judge Willie J. Epps, Jr. of the Western District of Missouri and Judge Paul C. Wilson of the Supreme Court of Missouri.
