

On October 18, 2024, U.S. District Judge Brian S. Miller presided over a Naturalization Ceremony in the Jacob Trieber Federal Court House in Helena, Arkansas. Students from DeSoto High School and Marvell Academy were invited to be a part of the ceremony.

Judge Miller, along with Federal Public Defender Lisa G. Peters, Chief U.S. Probation & Pretrial Services Officer G. Edward Towe, U.S. Marshal Cory Harris, U.S. Attorney Jonathan Ross, and Clerk of Court Tammy Downs, spoke to the students prior to the ceremony.

Brown Bag Learn at Lunch Series

The fall session of the Eastern District of Arkansas's Brown Bag Learn at Lunch Series for law clerks and externs began on October 30, 2024. Chief U.S. District Judge Kristine G. Baker focused this session on Arkansas history.

The presenters included Senior U.S. Circuit Judge Morris S. Arnold, who spoke on Arkansas Post, the first and most significant European establishment in Arkansas; U.S. District Judge Brian S. Miller, who spoke on the Elaine Massacre of 1919 in Helena; U.S. District Judge D.P. Marshall Jr., who spoke on the Cooper v. Aaron case, and included a tour of the 1957 Era-Faithful Courtroom in the Little Rock courthouse; U.S. Magistrate Judge Joe J. Volpe, who spoke on the Rohwer Internment Camp in southeastern Arkansas; and Clerk of Court Tammy Downs, who spoke on the history of the courthouse in the Eastern District of Arkansas.

Naturalization Ceremony Held in Fayetteville

On November 15, 2024, a Naturalization ceremony was held at the John Paul Hammerschmidt Federal Building in Fayetteville, presided over by U.S. Magistrate Judge Christy Comstock. Fifteen people from seven different countries were naturalized. In addition, a group of about 80 English as a Second Language students from Rogers High School attended the ceremony and then received more information from USCIS representatives. The students also met with U.S. Probation Officers, the U.S. Marshals Office, and heard more from guest speaker Mauricio Herrera who is a Criminal Justice Act panel attorney for the Western District of Arkansas.

Eastern District of Missouri

Eighth Circuit Court of Appeals

Second Cohort of The Supreme Court and My Hometown

In the fall of 2024, the Courts in St. Louis, Missouri, hosted another term of *The Supreme Court and My Hometown*, the national civics program of the Supreme Court Historical Society. This initiative engages high school students in a thorough study of the process and substantive issues of a case decided by the Supreme Court of the United States in a unique and personalized way. Participants learn how the Judicial Branch interacts with the other two branches of government and their roles and responsibilities as active citizens. A distinguishing feature of this program is the focus on Supreme Court cases that originated in the students' hometowns and local courts.

Twenty high school students were selected for the after-school program which featured *Hazelwood v. Kuhlmeier*, a landmark First Amendment student speech case. The program began with a 2-day orientation in July and continued after school on most Tuesdays throughout the fall semester.

Working with local attorney mentors, the students studied First Amendment law and every aspect of the case – from its trial in the Eastern District of Missouri, to oral arguments in the Eighth Circuit, to analyzing the opinion of the Supreme Court of the United States. Participants learned from first-person case participants and legal experts throughout the term and were able to demonstrate new skills through realistic courtroom simulation activities.




U.S. Circuit Judge Raymond W. Gruender, Eighth Circuit Court of Appeals, coached the student-justices and presided as Chief Justice during the moot court of *Hazelwood v. Kuhlmeier*.

For the capstone project, the students conducted oral history interviews with participants in the case, including the three plaintiffs, as well as local and national experts, to develop an archive of voices discussing the significance of the case. Short sections of the interviews will become permanent additions to the *Hazelwood v. Kuhlmeier* exhibit created by the 2023 cohort of *Hometowns* students, currently on display in the Judicial Learning Center. The student groups presented their capstone projects to the court family on December 10, 2024, at the closing celebration.

Outreach Event Held at Cheyenne River Indian Reservation

On November 14, 2024, employees from the District of South Dakota and attorneys from the South Dakota Indian Country Bar Association and the South Dakota State Bar Association travelled to Cheyenne-Eagle Butte Schools on the Cheyenne River Indian Reservation.

In the morning, third and fourth grade students participated in a mock trial based on "Goldie Locks and the Three Bears." In the afternoon, the entire high school student body participated in a mock trial based on the landmark 1883 Supreme Court case *Ex Parte Crow Dog*. Following the mock trials, a question and answer session was held for students to learn more from the legal professionals present about their professions.

The trip was organized by Seth Pearman, member of the Cheyenne River Sioux Tribe, Attorney General for the Flandreau Santee Sioux Tribe and president of the Indian County Bar Association. The event was sponsored by the South Dakota Indian Bar Association, the National Native American Bar Association, University of South Dakota School of Law, and the South Dakota Bar Association.

The following day, Mr. Pearman guest lectured in Myah Red Horse's tribal government class. He noted that the students were "incredibly engaged because of the Crow Dog trial the day before." In an interesting historical note, Myah's husband, Gayvn Spotted Tail, a member of the Rosebud Sioux Tribe, is a descendant of the victim, Spotted Tail, in the *Ex Parte Crow Dog case*.

Fifth Annual Bill of Rights Day Contest

In celebration of the anniversary of the Bill of Rights, district courts of the Seventh and Eighth Circuits collaborated to offer the fifth annual contest and virtual event. Students in grades 5-12 were encouraged to submit artwork and essays that identified a right that exists for people in other nations that they want to see added to the U.S. Constitution. In total, 319 students submitted 288 works of art and essays. The grand prize winners were announced during a live webinar on December 4, 2024, during which three federal judges spoke about their work and its relation to the Bill of Rights, and then took questions from the audience. U.S. Circuit Judge Jane Kelly, Eighth Circuit Court of Appeals, U.S. District Judge Andrea R. Wood, Northern District of Illinois, and U.S. Magistrate Judge Veronica Duffy, District of South Dakota, participated. Approximately 220 people participated in the webinar.
