District of North Dakota Civics Activities

In March, the District of North Dakota hosted two outreach events. Magistrate Judge Clare R. Hochhalter, Assistant U.S. Attorney Jonathan O'Konek, Assistant Federal Public Defender Erin Bolinger, and U.S. Probation Officer Megan Scherf traveled to Minot, North Dakota, to lead students at Our Redeemer's Christian School in a Bill of Rights program. They used materials designed around the Administrative Office's Bill of Rights Day program.

Chief District Judge Peter D. Welte and Magistrate Judge Alice R. Senechal welcomed over 40 students from Sheyenne High School in West Fargo, North Dakota, for the Administrative Office's Civil Discourse and Difficult Decisions program. This was the third year Sheyenne High School students have participated in the program at the Fargo courthouse. Judicial law clerks and attorneys recruited by the Federal Practice Committee assisted in presenting the program. Students were also able to tour the U.S. Marshals Service offices.

On February 26, 2025, a closing reception was held for the 2024 cohort of the Supreme Court and My Hometown-St. Louis, at which the student capstone project was unveiled. For the project, the students conducted oral history interviews with first person participants and other legal experts to enhance the Hazelwood v. Kuhlmeier exhibit created by the 2023 cohort.

The exhibit is displayed in the Judicial Learning Center in the Thomas F. Eagleton U.S. Courthouse in St. Louis. College Moot Court Competition Held

On March 7, 2025, the University of Iowa College of Law hosted the Van Ooosterhout-Baskerville Moot Court Competition. Participation in the competition is restricted to the top 32 appellate advocates in the second-year class. The top four competitors argued in a final round before a panel of four judges, including Chief U.S. District Judge Stephanie Rose, Southern District of Iowa.

State Mock Trial Competition Held in Little Rock

In March 2025, the Eastern District of Arkansas hosted the State High School Mock Trial Competition at the Richard Sheppard Arnold U.S. Courthouse in Little Rock, Arkansas. Seventeen teams from eleven high schools in Arkansas competed during the two day event. A total of 42 judges and staff members from the U.S. District Court, U.S. Bankruptcy Court, Clerk's Office, and the U.S. Probation Office volunteered their time to support the event.

U.S. District Judge James M. Moody, Jr. presided over the championship round. The team from Har-Ber High School in Springdale, Arkansas, won the competition. They will go on in May to represent Arkansas at the National High School Mock Trial Competition in Phoenix, Arizona.

Street Law Teacher Workshop

For over ten years, the federal courts in St. Louis have worked with the Missouri Bar Association to co-host a 2-day professional development workshop for high school teachers, led by instructors from Street Law, Inc. Street Law specializes in effective teaching strategies for civic and law-related education.

On March 6th and 7th, thirty teachers from Missouri and Illinois participated in the 2025 event. The workshop included a courtroom observation and a session on the Fourth Amendment from U.S. Magistrate Judge John M. Bodenhausen, Eastern District of Missouri, and culminated in a moot court activity in the Eighth Circuit's En Banc Courtroom.
