Mock Trial Held in Omaha

A Law Day mock trial based upon the famous fairy tale character Rumpelstiltskin was held at the Omaha, Nebraska, federal courthouse in May. The civil lawsuit was hosted by the Omaha Bar Association with help from actors with the Rose Theater.

Students from Paddock Road Elementary School took part as members of the jury, viewing gallery, and two students sat at the attorney's tables. Chief U.S. District Judge Robert F. Rossiter, Jr. presided over the civil trial, with Douglas County Attorney Don Kleine representing Rumpelstiltskin and Omaha defense attorney Joe Bradley representing Queen Mallory.

The trial was conducted in the similar fashion of an actual civil lawsuit. Chief Judge Rossiter explained to students throughout the trial what was taking place and why it was important to the proceedings. After a short debate, the jury ultimately found in favor of Rumpelstiltskin.



Classical Conversations Mock Trial participants are 8th grade homeschool students who meet weekly to study a variety of subjects, including rhetoric and logic. The students participating were beginning to learn debate, public speaking, and critical thinking skills. The event helped students exercise their skills rather than capture a verdict.

High School Students Participate in Mock Trial in Sioux Falls

A group of 36 high school students stepped into the shoes of legal professionals during a unique mock trial experience held in the courtroom of the federal courthouse in Sioux Falls, South Dakota. Organized by U.S. District Judge Karen E. Schreier and her law clerks, the event offered students a hands-on introduction to the American legal system and careers in law.

The mock trial was an integral part of the second annual Summer Law Camp hosted by the U.S. Attorney's Office for the District of South Dakota. The camp brought high school students from across South Dakota.

The mock trial centered around Ex Parte Crow Dog, an 1883 U.S. Supreme court case that held that the federal government lacked jurisdiction over crimes committed in Indian Country when all parties involved are Native American. Participants were able to take on a wide range of courtroom roles offering them a broad perspective on how the federal court system functions.


Girl Scout Mediation Simulation

Each summer, the federal courts in St. Louis, Missouri, partner with the National Park Service to co-host a badge workshop for the Girl Scouts. The Finding Common Ground badge helps participants work through a variety of ways to settle conflicts.

On June 5th, a group of local Girl Scouts earned their Finding Common Ground Badge. After spending the morning at the Old Courthouse at the Gateway Arch National Park, the group walked to the Thomas F. Eagleton Courthouse for simulated mediation activity in the afternoon. The participants were divided into teams and worked with attorney coaches to successfully resolve a cookie sales dispute with the help of a neutral party.



The Honorable Robert A. Katzmann Conference on Civics Education and the Federal Courts Held in St. Louis



A quote from the Hon. Robert A Katzmann about civics education in the United States

On April 24, 2025, the Honorable Robert A. Katzmann Conference on Civics Education and the Federal Courts was held at the Thomas F. Eagleton U.S. Courthouse in St. Louis, Missouri. The Katzmann Civics Conference was hosted by the Eighth Circuit and the Eastern District of Missouri. It was inspired by the first national federal courts' civics conference convened by the late Judge Robert A. Katzmann at the Thurgood Marshall U.S. Courthouse in New York City on October 31, 2019.

There were approximately 140 Conference participants, with judges and court staff from around the country in attendance. Also attending were representatives from five national civics education organizations that are members of the Civics Renewal Network, including the Leonore Annenberg Institute for Civics, at the University of Pennsylvania's Annenberg Public Policy Center, and 15 high school teachers of history, government, and civics, selected by the James Madison Memorial Fellowship Foundation.

The Conference consisted of a morning plenary session that began with welcoming remarks from the Chief Judges of the Eighth Circuit and the Eastern District of Missouri, as well as the Directors of the Administrative Office of the United States and the Federal Judicial Center, and Judge Sippel as Chair of the Judicial Conference Committee on the Judicial Branch. Chief Justice of the United States, John G. Roberts, Jr., provided a brief video in support of the Conference and judiciary civics education efforts that was shown during the welcoming remarks. The plenary session continued with an interview of Associate Justice Stephen Breyer, conducted by Judge Perry, and a session by Dr. Lance Holbert, Director, Leonore Annenberg Institute for Civics.

For most of the day, participants attended breakout sessions of their choice. There were a total of twelve sessions offered, with topics including:

Cooperative partnerships Learning centers and exhibits and displays Lifelong learning Supporting teachers

A lunchtime program featured the presentation of the Hon. Robert A. Katzmann Civics Impact Award. The Conference concluded with a summary session with reports from each of the breakouts. The nationwide conference will occur again in 5 years.
